- (i) Whether the defendants have infringed the registered trademark “RAJDHANI” of the plaintiff and if yes, to what effect? **OPP**
- (ii) Whether the defendants are passing off their goods as those of the plaintiff? **OPP**
- (iii) Whether the defendants have infringed the copyright of the plaintiff with respect to art-work/label “RAJDHANI”? **OPP**
- (iv) Whether the defendants are liable to be injuncted and restrained from using the mark “RAJDHANI” as part of their trade name? **OPP**
- (v) Whether the defendant is the prior user of the mark “RAJDHANI” for selling Masala and if yes, to what effect? **OPD**
- (vi) Whether the plaintiff is entitled to damages and if so, to what



effect?

(vii) Whether the goods of the plaintiff and defendants under the Trade Mark “RAJDHANI” are not similar so as to cause consumer confusion?

(viii) Whether the plaintiff has acquiesced to or consented to the defendant’s use of the mark “RAJDHANI”?

(ix) Whether the plaintiff were aware about the business of the defendants since the year 2005?

(x) Relief, if any.
