Matter is taken up through physical hearing as well as video conferencing.

I.P.A. 1/2021 (under Order XXXIII CPC)

As per file noting, service of respondent nos. 2 and 4 has not been completed as per order dated 05.05.2022. Inadvertently, in the last order, it has been mentioned that fresh summons be issued to respondent nos. 1 and 4, whereas it should have been mentioned as 'respondent nos. 2 and 4'.

Learned counsel for respondent nos. 1 and 3 has stated that he had not received the copy of the application, petition and documents till date due to which he could not file reply.



Learned counsel for the petitioner is directed to supply the soft copy of the application, petition and documents by way of e-mail within two days at the email ID of learned counsel for respondent nos. 1 and 3.

Learned counsel for the petitioner has stated that respondent no.2 is son and respondent no.4 is daughter of respondent no.1 and they are residing at the same address.

However, learned counsel for respondent nos. 1 and 3 has stated that respondent nos. 2 and 4 are not residing at the address of respondent no.1. He is directed to file the fresh addresses of respondent nos. 2 and 4 on record within 15 days and supply the same by way of e-mail to learned counsel for the petitioner to enable him to take steps for fresh service of respondent nos.2 and 4.

Fresh notice be issued to respondent nos. 2 and 4 on filing of PF within seven days, by all permissible modes including electronic mode and *dasti*, at the address mentioned in Memo of Parties/address to be provided by learned counsel for respondent nos. 1 and 3. Affidavit of service be filed atleast one week before the next date of hearing.

Put up for reply and report of service of respondent nos. 2 and 4 on 25th November, 2022.
