1. Counsel for the applicant submits that the applicant 'SHOPPING BAZZAR PVT. LTD.' is not the proprietor or owner of the Manoranjan Music Channel, which is the subject matter of the present suit and hence, seeks deletion from the array of parties.
2. Counsel for the plaintiff does not oppose the deletion.
3. In view thereof, the present application is allowed and the applicant,



Shopping Bazar Pvt. Ltd., is deleted from the array of parties.

4. Amended memo of parties showing Creative Channel Advtg. & Mktg. Pvt. Ltd. as the defendant no.5 be filed during the course of the day.
5. I.A 874/2023 has been filed on behalf of the applicant, Creative Channel Advtg. & Mktg. Pvt. Ltd. seeking deletion from the array of parties.
6. Counsel appearing for the applicant submits that the applicant shall not telecast/broadcast any copyrighted works that are the subject matter of the present suit on its channel. In view thereof, the applicant does not have any objection if a decree of permanent injunction as prayed for in prayer clause 44(1) of the plaint is passed against him.
7. Counsel for the plaintiff is agreeable for the same.
8. In view of the above, the counsel appearing on behalf of the plaintiff submits that the plaintiff does not press for other prayers against the defendant no.5.
9. Accordingly, a decree of permanent injunction in terms of prayer 44 (1) of the plaint is passed against the defendant no.5, Creative Channel Advtg. & Mktg. Pvt. Ltd.
10. Let decree sheet be drawn up accordingly.
11. Suit shall proceed against the remaining defendants.
