Accordingly, the present application stands disposed of.

CM APPL. 56203/2022

1. Learned counsel for the Petitioner, Association, states that the Respondent Nos. 1, 2 and 3 have not complied with the directions contained in paragraph no.6 of the order dated 05.04.2022 passed in the present proceedings, which reads as under:

“6. Let the reply indicate the measures that the Respondents intend to take to regularly monitor the area and to keep the said area free of encroachments.”

2. Mr. Udit Malik, ASC, GNCTD, appears for Respondent Nos. 1, 2 and



3 along with Mr. Sandeep Singh, Sub-Inspector, Delhi Police, P.S. Sadar Bazar. He states on instructions that the concerned SHO is assembling a permanent team consisting of Mr. Sandeep Singh, Sub Inspector, along with at least two constables, if not more, who will be assigned with the specific duty of supervising that there is no further violation of the orders dated 23.05.2017 and 20.10.2022, passed by this Court in W.P.(C) 11645/2016 and Cont. Cas (C). 375/2022, respectively. He states that the name and contact numbers of the constables will be provided to the Petitioner, Association and the three-member team will be at all times be available for enforcement of the aforesaid orders dated 23.05.2017 and 20.10.2022.

3. He further states that before the next date of hearing, due compliance of the orders dated 23.05.2017 and 20.10.2022 in letter and spirit shall be ensured by the Respondents and reported to this Court.

4. Learned counsel for the Respondent No.4 states that the Deputy Commissioner, North Delhi Municipal Corporation ('NDMC'), City S.P. Zone is responsible for ensuring due compliance of the orders dated 23.05.2017 and 20.10.2022. The name and contact details of the Deputy Commissioner may also be provided to the Petitioner, Association. He states that Respondent No.4 is taking all steps for complying with the orders. The said Deputy Commissioner is directed to ensure due compliance of the orders which are subject matter of the present proceedings.

5. Respondent Nos. 1, 2, 3 and 4 are directed to coordinate with each other in order to redress the grievances raised by the Petitioner in the present application.

6. Learned counsel for the Respondent Nos. 1 to 4 state that they will abide by the direction of holding a fortnightly meeting with the Petitioner,



Association.

7. With the aforesaid directions, taking the aforesaid statements of Respondent Nos. 1 to 4 on record and binding them to the said statement, the present application is disposed of.
