1. It is stated by learned counsel for the applicant/defendant no.1&3 that he has also filed some documents alongwith the captioned IA vide diary no.3251398. The same are on record.

2. Learned counsel for plaintiff accepts notice of the captioned IA and submits that he wants to file reply to the same.
