1. Learned counsel representing DTC, Mrs. Ahlawat, has explained the issue involved in this batch of writ petitions while highlighting that at least in four rounds, the Petitioners who fall in the category of 'express refusal', did not opt for pension scheme and have lost before the Courts.
2. She further submits that a majority of Petitioners have now filed the petitions through Associations after having lost in the previous round.
3. A chart explaining the aforesaid position has been handed over to the Court. She undertakes to e-mail the same to learned counsel representing the Petitioners who may file their respective charts.
