**I.A. No. 30110/2024 (by defendant for condonation of
delay of 9 days in filing WS to original plaint)**

1. Ld. Counsel for plaintiff submits that he does not wish to file any reply to the captioned IA and has no objection if the same is allowed.
2. Heard. For the reasons stated in the application and in view of above submissions, delay in filing the written statement to original plaint is allowed and the same be taken on record.
3. The captioned IA stands disposed off accordingly.

4. No reply to the captioned IA has been filed on behalf of the defendant. Ld. Counsel for the defendant submits that the contents of amended written statement may be read as reply to the captioned I.A.
