1. With the consent of the parties, *W.P.(C) 5260/2023*, titled as “*M L Lahoty Versus New Delhi Municipal Council*”, is treated as the lead matter.
2. Learned counsel appearing for the respondent-New Delhi Municipal Council (“NDMC”), submits that she has received rejoinders in two matters. She submits that she shall peruse the said rejoinders, and in case need be, file an additional affidavit with regard thereto. Liberty is so granted.
3. Learned counsel appearing for the petitioner in *W.P.(C) 5487/2023*, submits that the petitioner in the said case has expired, pursuant to which, an



application for impleadment of legal heirs of the said petitioner has been filed, which is pending before the Registrar.

4. He submits that he has instructions to file a rejoinder in the said petition, and he shall file the rejoinder only after the Legal Representatives (“LR”) of the deceased petitioner are brought on record.

5. The aforesaid statement is taken note of.

6. Accordingly, liberty is granted to file the said rejoinder.

7. Mr. Bhaskar Vali, learned counsel appearing for the petitioners in W.P.(C) 5724/2023, W.P.(C) 5744/2023, W.P.(C) 5750/2023, W.P.(C) 5843/2023, W.P.(C) 5844/2023, W.P.(C) 5903/2023, W.P.(C) 5947/2023, W.P.(C) 6028/2023, W.P.(C) 6297/2023, W.P.(C) 6299/2023, W.P.(C) 6318/2023, W.P.(C) 6344/2023, W.P.(C) 6458/2023, W.P.(C) 6508/2023, W.P.(C) 7518/2023, W.P.(C) 7667/2023, W.P.(C) 7682/2023, W.P.(C) 7688/2023, W.P.(C) 7716/2023, W.P.(C) 7739/2023, W.P.(C) 7886/2023, submits that he has instructions to file separate written submissions, as there are certain distinct issues in these petitions, which need to be addressed.

8. He further submits that the counter affidavit filed on behalf of the Land and Development Office (“L&DO”) was received by the petitioners, and he has instructions to file rejoinder to the same.

9. Accordingly, it is directed that an additional affidavit, in case need be, shall be filed by the NDMC, before the next date of hearing.

10. Likewise, rejoinder on behalf of the petitioners, wherever the petitioners wish to file such rejoinders, shall be filed before the next date of hearing.

11. Written submissions on behalf of the parties, along with the judgments that they wish to rely upon, shall be filed before the next date of



hearing.

12. Since W.P.(C) 5260/2023 is being treated as the lead matter, respective parties are at liberty to file their comprehensive written submissions in the lead matter itself.

13. It is made clear that the pending applications shall also be taken up at the time of hearing of the petitions.

14. Interim order to continue.

15. Accordingly, list for hearing on 19<sup>th</sup> December, 2025.
