The admission/denial has already been completed in the main suit.

Written statement filed by defendant is under objection. Objections be removed as per law, thereafter replication be filed in accordance with law.

Ld. counsel for the plaintiff/defendant no. 1 in counter-claim submits that she has filed the affidavit of admission/denial, vide dairy no. 3769398/2025 but no objection was raised by the registry and the same was taken on record. However, ld. counsel for the plaintiff submits that the written statement of plaintiff in



counter-claim was without affidavit of admission/denial and the affidavit of admission/denial has been filed after the period of 120 days, therefore the written statement of plaintiff/defendant no. 1 in counter-claim cannot be taken on record.

Both the parties are directed to file their written synopsis in not more than two pages within a week.

List the matter for the completion of pleadings on **04.02.2026**.

CC(COMM) 21/2022

Written statement filed by the defendant no. 2 is under objection. Objections be removed as per law, thereafter replication be filed in accordance with law.

IA No. 27952/2025 (By defendant no. 2 u/s 5 of the Limitation Act for condonation of delay in filing the written statement & affidavit of admission/denial)

Issue notice. Accepted.

Ld. counsel for the plaintiff submitted that the application may be allowed, subject to the costs. There is a delay of 92 days in filing the written statement to counter-claim and the same is condoned, subject to the costs of Rs. 4,000/- to be payable to the opposite party. Written statement of defendant no. 2 in counter-claim/defendant no. 3 in main suit be taken on record on the payment of costs within seven days and the time to file the replication shall only reckon from the date of payment of costs.
