1. Issue notices. Notices accepted by ld. Counsel for the plaintiff who presses for an opportunity to file a response. ld. Counsel for defendant no. 10 is directed to supply a copy each of both the IA's to ld. Counsel for the plaintiff on her email within three days. Let the replies be filed within four weeks, with an advance copy of the same to the opposite side. Rejoinders thereto, if any, be filed thereafter within two weeks of receiving advance copy of the replies. Put up again on the next date.



**CS(COMM)-303/2024:**

2. Defendant nos. 2 & 9 were served on 07.05.2024. Defendant no. 7 was served on 06.05.2024. Maximum permissible period for these three defendants to file a written statement has expired. Consequently, their respective rights to file a written statement stand closed. For defendant no. 6 today is the 118<sup>th</sup> day from the date of service of summons whereas for defendant nos. 1 and 3 to 5, it is the 119<sup>th</sup> day from the date of service. However, it needs a highlight that plaintiff is in active consultation with defendant nos. 1 to 6 for a mediated settlement. The next date before the ld. Mediator is scheduled for 06.09.2024.

3. Suit is already listed before the Hon'ble Court for 11.09.2024. Be placed before the Hon'ble Court on the date already fixed i.e. 11.09.2024, for further directions.
