1. This hearing has been done through hybrid mode.

2. These are applications filed by the Appellant - Sh. Ram Bharose, seeking suspension of sentence and grant of bail in **FIR No. 398/2006**, whereby vide judgment and order on sentence dated 2nd March, 2022 and 28th April, 2022, respectively, the Appellant was convicted to life imprisonment. The relevant portion of the order on sentence is set out below:

*“(i) Accused is hereby sentenced u/s 120B for an imprisonment for Life (RI) u/s 120B IPC. He is further shall be liable to pay a fine of Rs. 25,000/-, in default, 2 years SI.*

*(ii) Accused further shall be liable for imprisonment for Life (RI) under section 302 r/w 120B IPC. He further shall be liable to pay a fine of Rs. 1,00,000/-, in default, 2 years SI.*

*(iii) Accused further shall be liable for sentence for an imprisonment for Life (RI) u/s 3(2)(v) of SC/ST (POA) Act, 1989 r/w 120B IPC. He further shall be*



*liable to pay a fine of Rs. 1,00,000/-, in default, 2 years SI.”*

3. Ld. Counsel for the Appellant submits that the Appellant is 71 years of age and is suffering from heart conditions. It is further submitted that one of the co-accused *i.e.*, Neeraj in ***CRL.A.323/2022*** has already been given bail by this Court *vide* order dated 7th March, 2024, and the Appellant being a senior citizen also deserves bail.

4. Let the status report regarding the medical condition of the Appellant be called for from the concerned Jail Superintendent by the next date of hearing.

5. Let the nominal roll be also filed by the next date of hearing.

6. Copy of the order be communicated to the concerned Jail Superintendent.
