1. The present matter is at the stage of admission/denial of documents.
2. As per office noting, soft copy and hard copy of frehs Joint Document Schedule have been filed on behalf of the plaintiff.
3. Ld. Counsel for defendant no.1 already submitted that he has not filed any document in the present matter.
4. The plaintiff has already filed hard copies of documents, which were filed alongwith the plaint.



5. As per office noting, plaintiff has filed true typed copies of documents mentioned at page no.247 and 251 to 269 as per his original list of documents, vide diary no. 837135/2024 and he has also filed hard copies of the said documents.
