I.A. No. 21989/2023 on behalf of defendant no. 1 Santosh Nath for its deletion.

Defendant no. 3 has yet not been served, as is reflected from the order dated 21.08.2023. Ld. Counsel for the plaintiff is directed to take steps within a week for service of defendant no. 3 through all modes.

Registry records show that written statement on behalf of defendant nos. 2 & 6 is on record. Replications to the same have also been filed. Additionally, replications to the written statements of defendant nos. 1, 4 & 5 have also come on record but the record does not reflect the written statements on behalf of defendant nos. 1, 4 & 5. Final opportunity is granted to defendant nos. 1, 4 & 5 to bring their written statements on record within a



week failing which their respective rights to do so shall stand closed.
