**I.A. No. 21989/2023 on behalf of defendant no. 1 Santosh Nath for its deletion.**

1. On 20.02.2024, defendant no. 1 was directed to file its rejoinder to the present IA by 28.02.2024 since the matter was coming up before the Hon'ble Court on 29.02.2204. On 29.02.2024, however, the parties were referred to the Mediation Centre by the Hon'ble Court. On 10.07.2024 it was submitted before the Hon'ble Court that parties were still before the Mediation Centre. Subsequently, the matter was settled between the plaintiff and defendant no. 2 & 5. However, neither is there any appearance on behalf of defendant no. 1 today nor any rejoinder appears to have been filed to the present IA.



Consequently, right of defendant no. 1 to file a rejoinder stands closed. Put up for arguments on the next date.

**I.A. No. 22246/2023 filed on behalf of defendant no. 6 for its deletion.**

2. On 20.02.2024, ld. Counsel for the defendant no. 6 had prayed for some time to file a rejoinder. However, the Registry records do not show any rejoinder having been filed even after almost 9 months. Consequently, right to file a rejoinder stands closed. There is no appearance on behalf of defendant no. 6. Put up for arguments on the next date.

3. Pleadings qua defendants no. 1 & 6 are complete. Matter has already been decreed against defendants no. 2 & 5.

4. Ld. Counsel for the plaintiff submits that a final opportunity may be granted to serve defendant no. 3. Consequently, on steps being taken within two weeks issue summons to defendant no. 3 through all modes.

5. On 20.02.2024, defendant no. 4 was directed to bring its written statement on record within a week. However, till date written statement has not been brought on record. Consequently, given the time lag, right of defendant no. 4 to bring the written statement on record stands closed.

6. Put up for arguments in IA Nos. 21989/2023 & 22246/2023 on 10.02.2025.
