1. As per office noting, no.1 of the captioned IA has been served upon the plaintiff and defendants no.2 & 4 through their respective counsels.
2. Ld. Counsels for defendants no.2 and 4 submit that they do not wish to file any reply to the captioned IA and have no objection if the same is allowed.
3. Ld. Counsel for plaintiff submits that he has not received copy of the captioned IA. Ld. Counsel for defendant no.1 submits that he will supply the same during the course of the day. Let the same be supplied accordingly and after that, reply to the captioned IA be filed within two weeks and rejoinder thereto be filed within two weeks thereafter.
