I.A.9134/2020 (under Order VIII Rule 1 CPC –by defendant No.2) & I.A.9190/2020 (under Order VIII Rule 1 CPC –by defendant No.1)

1. By these two applications, defendant No. 2 and defendant No. 1 seek extension of time for 26 days in filing the Written Statements. Written Statements by defendant No. 2 and defendant No. 1 have already been placed on record.
2. Notice. Learned counsel for the plaintiff accepts notice.

CS (OS) 191/2020 & I.A. No.6086/2020 (under Order XXXIX Rules 1 and 2 CPC)

1. Plaintiff and defendant No. 1 are husband and wife. It appears that due to differences between the parties, property disputes are also arising, coupled with the fact that the interest of the two daughters is also affected. It would be thus appropriate to refer the parties to Mediation. Consequently, the plaintiff and defendant No. 1 are referred to Delhi High Court Mediation and Conciliation Centre where they would appear on 14.10.2020 at 04:00 PM in the first instance and, thereafter, as and when directed by the learned Mediator. Learned Mediator may also consider joining the two daughters of the plaintiff and defendant No. 1 in Mediation for a holistic settlement.
2. List the suit and the application on 20.01.2021, the date already fixed.
