I.A. No. 8449/2024 (u/order XXXIX Rule 1 & 2 CPC).

1. There is no appearance on behalf of defendant no. 1 which has been served on 15.10.2024. No reply has been filed on its behalf till now. Consequently, given the time lag, right of defendant no. 1 to file a reply stands closed.
2. Appearance on behalf of defendant no. 2 has been put in on 19.11.2024. No reply has been filed on their behalf. Final opportunity is granted to file a reply within three weeks failing which right to file reply shall stand closed without any further orders.
3. Rights of defendant nos. 3 & 4 to file a reply have already been closed. Defendant nos. 5 & 6 (collectively UOI) are not required to file a reply. Reply on behalf of defendant no. 7 is on record. Defendant no. 8 is John Doe. Reply on behalf of defendant no. 9 is stated to have been filed but is pending scrutiny.

I.A. No. 48193/2024 for seeking condonation of delay in filing replication to the written statement of def no. 7.

4. Ld. Counsel for defendant no. 7 accepts notice and submits that there is no objection to the present application. Consequently, delay in filing replication is condoned. Same is brought on record. A copy of the replication be supplied to Ld. Counsel for defendant no. 7 on his email within two days. IA stands disposed off.

Written statement has been filed by defendant no. 7 and replication thereto has also been filed. Pleadings are thus complete qua defendant no. 7 also. Defendant no. 8 is a John Doe. Written statement on behalf of defendant no. 9 is under scrutiny.

8. **IA No. 40091/2024** has been listed again although same has been disposed off. **Registry is directed not to list this IA again.**
