1. Reply on behalf of defendant no. 3 is already on record. It has further been recorded in regard to reply of defendant no. 3 that defendant no. 2 is satisfied with the response received.
2. So far as defendant no. 4 is concerned, as per the noting of the Registry, notice could not be issued since PF has not been



filed. However, in a previous order it has been recorded that PF stands filed. Nevertheless, defendant no. 2 is directed to file PF again within ten days and thereafter, notice be issued to defendant no. 4. Reply be filed within four weeks of receiving a reply. Put up for completion of pleadings.

3. Replies on behalf of defendant nos. 7 and 9 are on record. Ld. Counsel for the plaintiff submits that two more weeks may be granted to file rejoinders to the same.

4. It needs a highlight that rights of defendant nos. 1, 2 and 3 to file a reply to this IA have already been closed.

5. Defendant no. 4 has not put in appearance till date despite being served on 29.05.2024 (recorded in the order dated 16.07.2024). Defendant nos. 5 and 6 have already complied with the directions and no reply is to be filed on their behalf in the present IA.

6. Put up for completion of pleadings on 14.11.2025.
