Matter is taken up through physical hearing as well as video conferencing.

Perusal of file noting reveals that defendant no. 1 to 8, 10, 11 and 13 to 15 have been served with summons by way of ordinary mode. Service report by other modes is awaited.



Perusal of file noting ~~from~~ reveals that Written Statement vakalatnama filed on behalf of defendant no.1 is lying under objection. However, advance copy was served upon plaintiff and plaintiff has filed Replication to the Written Statement of defendant no.1, which has been cleared by the Registry subject to Court Order.

Ld. Counsel for plaintiff has stated that no supporting documents have been filed by defendant no.1 with Written Statement, due to which replication has been filed without affidavit of admission/denial. Defendant no.1 is directed to remove objections within one week so that Written Statement and vakalatnama comes on record.

At this stage, Ld. Counsel for defendants no. 7,8, 9, 10 and 11 has appeared alongwith defendants no. 7 and 8 and stated that he has filed his vakalatnama and he seeks some more time for filing Written Statement. At request, complete set of plaint and documents be supplied to abovesaid defendants through counsel within one week by way of e-mail. Counsels for the parties are directed to share their e-mail IDs in attendance.

Defendants no.3,5,6,12,13,14 and 15 have appeared in person and stated that they have received the complete set of plaint and documents and they seek some more time for filing Written Statement. Written Statement alongwith affidavit of admission/denial and documents if any and Reply to interim applications be filed by all the defendants within prescribed limitation period with advance copy to the plaintiff.

Be fixed for completion of pleadings on 07.10.2024.
