Matter is taken up through physical hearing as well as video conferencing.

As per file noting, Written Statement alongwith affidavit of admission/denial has been filed by defendant no.1 Replication to the Written Statement of defendant no.1 has been filed by plaintiff. **Pleadings are complete qua defendant no1.**

However as per file noting, Written Statements filed by defendants no. 2 to 6 and defendant no. 7 to 11 are lying under objections. Copy supplied.



Ld. Counsel for plaintiff has objected that the said Written Statements have been filed beyond statutory period of 30 days from date of service and no application for condonation of delay has been filed by defendants.

Last opportunity is granted to defendants no. 2 to 6 and 7 to 11 for filing application for condonation of delay within two weeks with advance copy to plaintiff. The applications for condonation of delay shall be considered on merits.

At request, copy be supplied to Ld. Counsel for plaintiff. All the defendants are directed to share their pleadings with each other by way of e-mail. Ld. Perusal of previous order reveals that defendant no. 13,14 and 15 had appeared in person on the last date of hearing but none has appeared on their behalf today and they have not filed any pleadings.

Last opportunity is granted to defendants no. 13,14 and 15 for filing Written Statement if any alongwith application for condonation of delay subject to law of limitation, with advance copy to Ld. Counsel for plaintiff.
