3. The present petition under Article 226/227 of the Constitution of India read with Section 528 of the BNSS seeks the following prayers: -

“I. Issue writ/order/directions in the nature of mandamus or any other appropriate writ/order/directions, thereby directing the respondents herein to disclose if any Look Out Circular is pending against the petitioner qua the following cases- A) RC NO. 220/2014/E/0010, B) RC NO. 220/2014/E/005, C) RC NO. 220/2014/E/006- CBI/EOU-V/EO-II, D) 220/2014/E/0009-CBI/EOII/ EOU-V/NEW DELHI, E) 220/2014/E/0013/EOUV /EO-II/NEW DELHI, & F) 220/20 16/E/00 12/CBI/EOU-V /EO-II/NEW DELHI; and

II. Issue writ/order/directions in the nature of mandamus or any other appropriate writ/order/directions, thereby directing the respondents herein to quash or withdraw forthwith such Look Out Circulars, if any, in force against the petitioner, and any consequent



proceedings thereof; and/or  
Pass any other order(s) as this Hon'ble Court may deem fit and proper in  
the circumstances of the case.”

4. Learned Senior Counsel appearing on behalf of the petitioner submits that the latter is facing trial in 6 cases initiated against him on behalf of the CBI. It is submitted that the petitioner was informed that a LOC has been opened against him at the instance of the respondent No.2/CBI. Accordingly, a representation dated 17.03.2025 was preferred to respondent No.2/CBI seeking information whether any LOC has been issued against the present petitioner or not. It is further submitted that no response to the same has been received till date. Hence, the present petition.

5. Issue notice.

6. On the petitioner taking necessary steps, issue notice to respondent No.2/CBI, at this stage, through all permissible modes, including electronic mail, if any, returnable on 16.05.2025.
