1. As per office noting for 01.02.2023, replication was filed on behalf of the plaintiff on 19.12.2022.
2. It is submitted that no documents was filed on behalf of the defendants, therefore, affidavit of admission/denial of documents is not required to be filed by the plaintiff.
3. Pleadings in the matter are complete.
4. As per office noting for today, Joint Document Schedule was filed on behalf of plaintiff on 08.02.2023.



5. IA filed vide diary no. 157105 dated 06.11.2022 has yet not come on record. Let needful in this regard be done.
6. Ld. Counsels for both parties submit that the document mentioned at sr. no.13 in the affidavit of admission/denial of documents filed vide diary no.1588498/2022, account no. in the name of Ms. Aziza Jafri is wrongly mentioned as 173604501500554 instead of 173601000002774. They further submit that the said account no. is also incorrectly mentioned at sr. no.14 in Joint Document Schedule. They further submit that the said account no. is correctly mentioned on the document. With the consent of both the parties, wrong account no. 173604501500554 has been struck off and correct account no. 173601000002774 has been written, under signatures of both the parties, at sr. no.13 in the affidavit of admission/denial of documents filed vide diary no.1588498/2022 and at sr. no.14 in the Joint Document Schedule.
7. Ld. Counsel for defendant has submitted that through the defendant has admitted all documents filed on behalf of the plaintiff, however, the defendant now does not admit the document as mentioned at sr. no.7, 8 & 11 in affidavit of admission/denial filed vide diary no.1588498/2022 and as mentioned at sr. no.8, 9 & 12 in the Joint Document Schedule, as the said documents are not complete. Ld. Counsel for plaintiff also concedes to the said fact.
