7. As per office note for 03.08.2023, service report of defendant no.1 and 4 is awaited. Affidavit of service was filed by the plaintiff on 05.09.2023. Learned counsel for defendant no.1 had entered appearance on 12.09.2023.

He seeks time to move an application for deletion of defendant no.1 from the array of parties. Same be filed within two weeks. Defendant no.4 was served through courier on 27.07.2023. None has appeared for defendant no.4. No written statement has been filed by defendant no.4 till date. The right of defendant no.4 to file



written statement is closed.
