I.A. No. 9113/2022 (u/O XXXIX Rules 1 & 2 CPC).

1. It is submitted that the captioned IAs are coming up for hearing before the Hon'ble Court on 11.11.2022.

I.A. No. 17927/2022 (u/S 151 CPC for exemption from filing clear/original copies of Annexures/documents with proper font size, spacing and margin by defendant no.1).

1. Heard. Not opposed.
