2. **CRL.M.(BAIL) 68/2026** in **CRL.A. 404/2020** has been filed seeking suspension of sentence. After having seen the gruesome nature of the matter, the Court is not inclined to suspend the sentence of the Appellant.
3. It appears that **CRL.A.463/2020** titled **Madu @ Rahim v. State of NCT of Delhi** was wrongly mentioned in the order dated 10th February, 2026. In fact, the correct number would be **CRL.A. 463/2022** titled **Pradeep Kumar v. State of NCT of Delhi & Anr.** which arises from the impugned judgment. Since all these appeals relate to the same impugned judgment, the appeals *i.e.*, **CRL.A. 404/2020**, **CRL.A. 545/2020** and **CRL.A. 463/2022**, may be placed before the Hon'ble the Chief Justice for listing before the same Division Bench.
