**I.A. 22490/2023 (Application under Order I, Rule 10(2) read with
Section 151 CPC)**

1. The present application has been filed under Order I Rule 10(2), read with Section 151 of Code of Civil Procedure, 1908 ("CPC"), on behalf of the plaintiff seeking impleadment of DHI Global Limited, represented through the plaintiff, as plaintiff no.2 in the present suit.
2. Learned counsel appearing for the plaintiff submits that the present suit has been filed claiming disparagement and infringement of his licensed trademark in respect of two different grossly wrong, disparaging and denigrating videos published by the defendant on his online YouTube



Channel.

3. He further submits that under the Master Franchise Agreement dated 18th January, 2018, the plaintiff has been permitted by the DHI Global Pvt. Ltd., to use the DHI Technique (DHI Know-How) conducted using patented instrument, under the trademark DHI to undertake, promote and develop the business of providing hair restoration service.

4. It is submitted that DHI Global Ltd. is the owner and franchisor of the 'DHI Know-How', including, the 'DHI Technique', which is a collection of various steps and procedures and licensed to the plaintiff company. Thus, it is submitted that by virtue of the said Master Franchise Agreement, the plaintiff has been able to harness and gain immense goodwill and reputation of its own in India.

5. This Court notes that vide order dated 07th November, 2023, predecessor bench of this Court has already granted liberty to the plaintiff herein, to take necessary steps for filing an application for impleadment.

6. Accordingly, considering the submissions made before this Court, the present application is allowed.

7. The DHI Global Ltd. is accordingly impleaded as plaintiff no.2 in the present suit.

8. Let amended memo of parties be filed within a period of ten days from today.

9. With the aforesaid directions, the present application is disposed of.
