Ld. counsel for the plaintiff submitted that the application may be allowed, subject to the costs. The delay of 89 days in filing the written statement, same is condoned, subject to the costs of Rs. 5,000/- to be payable to the opposite party.

IA No. 26550/2025 (u/s 151 CPC for filing plaintiff's unredacted replication physically in a sealed cover & separately

IA No. 29437/2025 (By defendants u/s 151 CPC (as amended by CCA) seeking condonation of delay in filing the rejoinder to IA No. 16376/2025)

Reply has been filed by the plaintiff.

Ld. counsel for the defendant submitted that he does not want to file any rejoinder.
