I.A. 40226/2024 (Application u/O XXII Rule 3 CPC filed by plaintiff to implead/substitute legal heirs of plaintiff)

Ld. Counsel for plaintiff has stated that names of all the first class legal heirs of the deceased plaintiff have been mentioned in the application and there are no other legal heirs required to be impleaded except the persons mentioned in the application.
