CRL.A. 533/2025

1. The present appeal under Section 415(2) read with Section 528 of B.N.S.S., 2023 has been filed on behalf of the Appellant against the Judgment dated 22.01.2025 and the Order on Sentence dated 21.03.2025 passed by the Ld. ASJ-01 (POCSO), North, Rohini Courts, Delhi in Sessions Case No.369/2021. By the Judgment dated 22.01.2025, the Appellant has been convicted for the offence punishable under Section 376(2) IPC and Section 6 of POCSO Act in FIR No.284/2021, registered at Police Station K.N.K Marg. By the Order on Sentence dated 21.03.2025, the Appellant has been sentenced to undergo rigorous imprisonment for life along with a fine of Rs.10,000/- for the offence punishable under Section 6 of POCSO Act. In case of default in payment of fine, the Appellant shall



further undergo imprisonment for a period of one month.

2. Admit.

3. Let a digitized copy of the Trial Court Record (TCR) be requisitioned before the next date of hearing.

4. The Registry is directed to provide a copy of the paper book to the learned Counsel for the Appellant and the learned APP for the State.

5. List in due course.

CRL.M.(BAIL) 893/2025

1. This application under Section 430 read with Section 528 of B.N.S.S., 2023 has been filed on behalf of the Appellant for suspension of sentence and release of the Appellant on bail during the pendency of the appeal.
