1. It is submitted that the matter and captioned IA are coming up for hearing before the Hon'ble Court on 10.11.2022.
2. Ld. Counsel for plaintiffs submits that he is also appearing on behalf of defendant no.3 i.e. Ram Pyari Trust and his vakalatnama along-with authority letter on behalf of defendant no.3 is also on record vide diary no.1083978 dated 04.07.2022.
3. On the other hand, Ms. Manyaa Chandok, Advocate submits that she is appearing on behalf of defendants no.1 & 2 as well as on behalf of defendant no.3 i.e. Ram Pyari Trust. She further submits that she will file her vakalatnama within two days.



4. Ld. Counsel for plaintiffs and Ld. Counsel Ms. Manyaa Chandok shall clarify on next date of hearing as to who will represent the defendant no.3 in the present matter.
5. Ld. Counsel for plaintiffs submits that he intends to withdraw his vakalatnama filed vide diary no.1065094 dated 01.07.2022 because due to some inadvertent mistake, the same has been filed on behalf of defendant no.4, however, details of defendant no.3 are mentioned in the same. He further states that he has already filed his fresh vakalatnama on behalf of defendant no.3 vide diary no.1083978 dated 04.07.2022.
6. Heard. In view of submissions, Ld. Counsel for plaintiffs is permitted to withdraw his vakalatnama filed vide diary no.1065094 dated 01.07.2022. Let the same be taken off the record.
7. As per office noting, affidavits of service filed on behalf of plaintiffs vide diary no.1051518 dt. 6.6.2022 and 1412678 dt. 23.8.2022.
8. In view of affidavits of service, defendant no.4 has been served.
9. All the defendants may file their written statement, reply to the captioned IA and affidavit of admission/denial of documents as per law with advance copy to the plaintiffs, who may file replication, rejoinder and affidavit of admission/denial of documents.
10. Re-notify the matter for completion of pleadings and admission/denial of documents on **17th October, 2022**.
