CM APPL. 25046/2024 (exemption)

1. Allowed, subject to all just exceptions.
2. The application stands disposed of.

CM APPL. 25044/2024 (delay of 2 days)

3. In view of the reasons mentioned in the application, delay of 02 days in filing the appeal is condoned.
4. The application stands disposed of.

CM APPL. 25045/2024 (seeking extension of time to make up the deficiency in the court fee)

5. The present application is filed on behalf of the appellant under section 149 of the C.P.C seeking extension of time to make up the deficiency in the court fees.



6. For the reasons stated in the application, the application is allowed and 08 weeks' time is granted to make up the deficit in the court fee.
