CM APPL.11557/2025 (u/S 5 of the Limitation Act)

1. This is an application under Section 5 of the Limitation Act seeking condonation of delay of 18 days in moving the application under Order 22 Rule 3 CPC.
2. In view of application under Order 22 Rule 3 CPC having been allowed in connected matter being RFA 769/2023 on 10.02.2025, the present application is allowed and delay of 18 days is condoned in filing the application under Order 22 Rule 3 CPC.
3. Application stands disposed of.
