7. He submits that the petitioner, in order to show its *bona fide*, will also deposit 50% of the cheque amount before the learned Appellate Court.

10. On the petitioner depositing a sum of ₹1,50,000/- before the learned Appellate Court within a period of six weeks, the operation of the order dated 21.01.2025 is stayed till the next date of hearing.
