1. CONT.CAS(C) 703/2021: Counsel for Municipal Corporation of Delhi (*'MCD'*) states that Status Report is not required as MCD stands in support of case of the Federation.
2. W.P.(C) 6823/2017: Status report, if not placed on record, within three weeks, the cost of Rs. 25,000/- shall be liable to be paid.
3. CONT.CAS(C) 1210/2022: Status report of Delhi Development Authority (*'DDA'*) which is filed in W.P.(C) 8430/2021 be considered. Let the copy of the said report be placed on record.
4. W.P.(C) 7307/2017: *Mr. Mukesh Kumar Gutpa*, counsel for MCD states that in spite of order dated 17th October 2025 of this Court, since the earlier status report is on record, he has instructions not to place any additional status report on record. Statement coming on instructions is accepted. Legal consequences shall follow.
5. W.P.(C) 9611/2017: *Mr. Gupta* is granted three weeks as last chance to file further status report.
6. W.P.(C) 8430/2021: Counsel for respondent no.1/New Delhi Municipal Corporation (*'NDMC'*) states that, NDMC is not a necessary or appropriate party to the proceedings as the issue which is sought to be canvassed does not fall within its territorial limits. As such, deletion is



sought. The prayer for deletion is not objected to; hence, same stands allowed. Counsel for GNCTD who appears through VC is granted three time to file the status report. Status report by counsel for MCD, if not placed on record, within three weeks, the cost of Rs. 25,000/- shall be liable to be paid.

7. W.P.(C) 6221/2022: Counsel for MCD is granted three weeks' time to file the status report by way of last chance.
