As per office note, fresh Vakalatnama filed on
behalf of the plaintiff is on record.

It was recorded on the last order dated 27.01.2025
that the plaintiff is not diligently pursuing the present
matter. It was further ordered that heavy cost would be
imposed upon the plaintiff in case of any further
negligence on the part of the plaintiff to pursue the present
matter. Despite the same, the plaintiff has not taken any
requisite steps for impleading the LR's of deceased



defendant no.2 till date for which no plausible explanation is furnished by the plaintiff for not steps till date. So, cost of Rs.4000/- is imposed upon the plaintiff and now, the last and final opportunity is granted to the plaintiff to take all necessary steps for impleadment of LRs of deceased defendant no.2 as per law within three two weeks.

As per record, Written Statement alongwith Affidavit of Admission/Denial of the documents and documents have been filed by defendant no.1 in the year 2021. As per submission of learned counsel for defendant no.3, the matter was later on compromised by plaintiff, defendant no.1&2 to deceive the defendant no.3. The right of the plaintiff to file Replication alongwith Affidavit of Admission/Denial of the documents qua defendant no.1 was ordered to be closed vide order dated 27.01.2025.

Further, no Written Statement has been filed by defendant no.2 till date.

Further as per record, Written Statement alongwith Affidavit of Admission/Denial of the documents and documents filed by defendant no.3 have been placed by the registry. However, an application for condonation of delay in filing Written Statement filed by defendant no.3 is pending consideration.

Re-notify the matter for proceedings on 09.05.2025.
