1. On the last date of hearing, it was informed that the appellant was advised to undergo *TRODAT SPECT (scan)*.
2. Ms. Sonia Mathur, learned Senior Counsel for the appellant submits that the appellant has undergone the requisite scan, the report of which was received on 15.02.2022 and now has to be clinically correlated. She submits that during his dental review, the appellant was also advised oral surgery.
3. Learned Senior Counsel, on instructions, submits that the appellant requires 10 days' time to undergo the necessary clinical evaluation.
4. Mr. Nikhil Goel, learned SPP for the respondent/CBI submits that there is as such no emergency in the present medical status of the appellant and he can be treated on OPD basis in jail.
