ORDER

1. On 08.04.2022, this Court recorded the operative portion of the status report from the Jail Superintendent which stated that the physiotherapy services available in jail would not be sufficient for the appellant.
2. I am of the opinion that the conviction of the appellant is under Section 304(II)/120B/193/201/203/211/323/341 IPC read with Section 3 and 25 of the Arms Act. The appellant has been in custody since 10.04.2018 and was granted medical bail vide order dated 12.11.2020. It is an admitted fact that the appellant is suffering from oral mouth cancer and has been operated on 23.10.2020. Thereafter, the appellant has been undergoing rehabilitative physiotherapy as a part of his jaw has been removed.
3. In addition, the appellant is also suffering from Dystonic Tremors which, according to the learned counsel for the appellant, affects his



day-to-day functioning.

4. The appellant shall appear before a Committee of Doctors from All India Institute of Medical Sciences (AIIMS) who shall, after investigation, opine that:-
 - (a) Whether the appellant will be able to perform his day-to-day functions;
 - (b) Whether the post operative recovery can be performed while he is in custody.
5. The Director, AIIMS is requested to constitute a Board of Doctors to do the needful within a period of 2 weeks from today. The appellant shall appear before the Board on 02.09.2022, and the report shall be filed within a week thereafter.
6. Once the Board is constituted, the appellant shall be informed on the following email IDs:

7. Re-notify on 13.09.2022.
8. Interim orders to continue till the next date of hearing.
