1. Learned Senior counsel for the applicant submits that since in terms of the order dated 20.07.2022, a fresh application has been moved bearing Crl.M.(BAIL) No.897/2022, so the present application, i.e., CRL.M.(BAIL) 50/2022 is not pressed and the same is disposed of accordingly.

3. In terms of the order dated 18.08.2022, the board constituted at AIIMS has submitted its report dated 13.09.2022. Let copy of the said report be sent to the Jail Superintendent with a direction to get the opinion of the Jail doctor confined to the fact (i) as to whether the present applicant can be provided the requisite physiotherapy facilities either in the jail hospital or in a hospital attached with the jail. (ii) whether in case of partial incapacity of the right hand of the applicant, can he be provided an assistance as mentioned in the said report dated 13.09.2022 to manage his day-to-day activities while in jail.
- 3.1 Let the report be submitted within two weeks from today.
4. Copy of this order along with the report received of the board from AIIMS be sent to the Jail Superintendent.
5. List on 05.12.2022.
6. Interim orders will continue to operate till the next date of hearing.
7. The applicant shall be present before the jail authorities on 16.11.2022 at 11:00 a.m. and he shall appear before the jail authorities/jail doctor as and when directed even thereafter.
8. The order be given *dasti* under the signatures of the Court Master.
