1. This hearing has been done through hybrid mode.

CRL.M.A. 17848/2026 (Exemption)

2. Allowed, subject to all just exceptions. The application is disposed of.

CRL.A. 565/2026

3. The present appeal under Section 415 of the BNSS has been filed assailing the impugned judgment of conviction and order on sentence dated 04.05.2026 and 15.05.2026 respectively passed by learned ASJ (FTC), Shahdara District, Karkardooma Courts, Delhi, whereby, the appellant has been convicted in SC No. 369/2018, arising out of FIR No. 113/2018, under Section 25 of the Arms Act, 1959, registered at P.S. Shahdara.



4. *Vide* the impugned judgment of conviction and order on sentence, the appellant has been convicted for the offence punishable under Section 25 of the Arms Act and sentenced to undergo imprisonment for two and half years alongwith fine of Rs. 25,000/-, and in default of payment of fine, he is further directed to undergo simple imprisonment for a period of six months.

5. Admit.

6. The Registry is directed to requisition the Trial Court Record with proper index, pagination and bookmarks for perusal of this Court by the next date of hearing. Let the paperbook for the same be also prepared.

CRL.M.(BAIL) 1139/2026

7. The present application under Section 430 (3) read with Section 528 of the BNSS seeks suspension of sentence and release of the appellant/applicant on bail during pendency of the instant appeal.

8. Learned counsel for the applicant/appellant submits that *vide* order dated 15.05.2026, the learned Trial Court has suspended the sentence till today.

9. Issue notice.

10. Learned APP for the State accepts notice and seeks time to file a status report. Let the same be filed before the next date of hearing.

11. List on 18.08.2026 before Roster Bench.

12. The sentence of the applicant/appellant is suspended till the next date of hearing on the same terms and conditions as incorporated in order dated 15.05.2026 passed by the learned Trial Court.

13. In the meantime, latest nominal roll be requisitioned from the concerned Jail Superintendent.

14. Copy of the order be sent to the concerned Jail Superintendent, for



necessary information and compliance.

15. Order be uploaded on the website of this Court, *forthwith*.
