List/put up on 02.07.2026 at 02.30 PM to enable the learned counsel representing the Indian Olympic Association and Union of India to seek instructions as to whether any competitive event is logistically possible in terms of Clause 15-(b) of the Selection Criteria Version-IV as framed by Equestrian Federation of India, which has been enclosed as Annexure A-6 to this appeal, before 15.07.2026 which is the last date of making the nomination for participation of the sportspersons in 20th Asian Games – 2026 at Japan.
2. We direct that the competent authority of the Union of India will be at



liberty to consult the experts on the issue as to whether the competition as mentioned above is logistically possible within the period as observed above.
