1. It is submitted that the captioned IA is coming up for
hearing before the Hon'ble Court on 26.07.2024.

**I.A. 8734/2024 (by LR's of plaintiff for filing additional

2. It is submitted that the captioned IA is coming up for
hearing before the Hon'ble Court on 26.07.2024.



3. Ld. Counsel for defendants no.1 & 2 accepts notice of the captioned IA and submits that he has not received copy of the same. Let copy of the captioned IA be supplied to Ld. Counsel for defendants no.1 & 2 within one week. Let the same be supplied accordingly and thereafter, reply to the captioned IA be filed within two weeks and rejoinder thereto be filed before next date of hearing.
4. Issue notice of the captioned IA to the remaining served defendants through counsel for next date of hearing, who may file reply to the same within four weeks from the date of service of notice and rejoinder thereto be filed within two weeks thereafter.

5. It is submitted that matter and captioned IA are coming up for hearing before Hon'ble Court on 26.07.2024.
6. Written statement and affidavit of admission/denial of documents already filed on behalf of the defendants no.1 and 2.
7. No replication and affidavit of admission/denial has been filed on behalf of plaintiff qua defendants no.1 and 2 and application for condonation of delay in filing replication filed by plaintiff has already been dismissed by Hon'ble Court vide order dated 15.04.2024.
8. Ld. Counsel for defendants no.1 and 2 already submitted that he did not wish to file any reply to the captioned IA.
9. No written statement, affidavit of admission/denial and reply to the captioned IA has been filed on behalf of both LR's of defendant no.5.
10. As per office noting, summons not issued to defendants



no.3, 4, 6 and 7 as PF was returned under objection.

11. Issue summons of suit and notice of the captioned IA to the defendants no.3, 4, 6 and 7 through all permissible modes for next date of hearing.
12. The defendants no.3, 4, 6 and 7 shall file their written statement, affidavit of admission/denial of documents and reply to the captioned IA within 30 days from the date of service of summons with advance copy to the plaintiff, who may file replication, affidavit of admission/denial of documents and rejoinder qua the captioned IA thereafter within 30 days.
13. Let the pleadings be completed as per law.
14. Re-notify the matter and captioned IA for completion of service, completion of pleadings and further proceedings on **19th July, 2024**.
