4. Vide order dated 08.05.2024, the Hon'ble Court directed that the summons be issued to all unserved defendants for the next date.

5. As per office note, summons could not be issued as PF was returned under objections. Last and final opportunity is granted to the plaintiff to take steps positively within three days.

6. Issue fresh summons and notice of pending IAs to defendant nos. 3, 4, 6 & 7 through all permissible modes on filing of PF returnable for next date. At request, process be also given dasti.

7. Written statement has been filed by defendant nos. 1 & 2 only. The right to file replication to written statement of defendant nos. 1 & 2 has been closed vide order dated 15.04.2024. Written statement be filed by LRs of defendant no.5 in accordance with the provisions of law.

7. Learned counsels for parties submit that the matter is listed before the Hon'ble Court on 26.07.2024. The file may be placed before the Hon'ble Court on date already fixed i.e. 26.07.2024 for further directions.
