1. It is submitted that next date of hearing for 19.10.2022 was advanced by the Hon'ble Court for today.

4. The plaintiff may file replication and affidavit of admission/denial of documents as per law with advance copy to the opposite party.

6. The defendant no.8 may file written statement alongwith affidavit of admission/denial of documents as per law with advance copy to the opposite party, who may file replication alongwith affidavit of admission/denial of documents as per law.
7. The defendant no.8 may file reply to the captioned IA within four weeks with advance copy to the plaintiff, who may file rejoinder



within two weeks thereafter.

8. Issue fresh summons of the suit and notice of captioned IA to the unserved defendants through all permissible modes for next date of hearing.
9. Re-notify the matter and captioned IA for completion of service, completion of pleadings and further proceedings on **20th January, 2023.**
