1. It is submitted that the captioned IA is coming up for hearing before the Hon'ble Court on 23.02.2023.
2. As per office noting, reply to the captioned IA was filed on behalf of the plaintiff on 02.12.2022.
3. No rejoinder to the reply of plaintiff has been filed on behalf of defendants no.1 and 2. Time sought. Let the same be filed within three weeks from today.
4. Re-notify the captioned IA for completion of pleadings and further proceedings on **13th February, 2023.**



**CS(OS) 417/2022 & I.A. No. 11265/2022 (u/O XXXIX
Rules 1 & 2 of CPC)**

1. As per service report, defendants no.3 to 7 have remained unserved.
2. Vide order dated 10.11.2022 passed by Hon'ble Court, the defendant no.8 Standard Chartered Bank was ordered to be deleted from the array of parties subject to filing the title deeds as mentioned in order dated 10.11.2022.
3. Ld. Counsel for the parties appearing today submit that they have no information from defendant no.8 in respect of deposit of any title deed.
4. There is no appearance on behalf of defendant no.8.
5. In the present facts and at request, **issue court notice to defendant no.8 through counsel for next date of hearing.**
6. Written statement and affidavit of admission/denial of documents already filed on behalf of the defendants no.1 and 2.
7. No replication and affidavit of admission/denial has been filed on behalf of plaintiff qua defendants no.1 and 2.
8. No separate reply qua the captioned IA was filed on behalf of the defendants no.1 and 2. Time sought. Let reply to the captioned IA be filed within four weeks from today with advance copy to the opposite party, who may file rejoinder within four weeks thereafter.
9. Ld. Counsel for plaintiff submits that he has not received copies of documents filed on behalf of defendants. Ld. Counsel for defendant submits that he will supply the same within one week from today. Let the same be supplied accordingly.



10. The plaintiff may file application alongwith affidavit of admission/denial of documents qua defendants no.1 and 2 as per law.
11. As per service report, defendant no.5 has been served through ordinary mode. There is no appearance on behalf of the defendant no.5.
12. The defendant no.5 may file written statement alongwith affidavit of admission/denial of documents as per law with advance copy to the opposite party, who may file rejoinder within two weeks thereafter.
13. At request, issue fresh summons of the suit and notice of captioned IA to the defendants no.3, 4, 6 and 7 through all permissible modes for next date of hearing.
14. Re-notify the matter and captioned IA for completion of service, completion of pleadings and further proceedings on **13th February, 2023**.
