1. This is an application filed on behalf of the defendant No. 4, Google LLC under Order XXXIX Rule 4 CPC seeking modification of order dated 29.07.2022.
2. Learned Senior Counsel appearing for the applicant submits that



only one URL was provided by the plaintiff to defendant No. 4 and the same has been disabled by defendant No. 4. It is further contended on behalf of defendant No. 4 that the plaintiff may provide any other URLs and that requisite action shall be taken by the defendant No. 4 accordingly as and when such URLs are provided by the plaintiff. It is further prayed that in case the defendant Nos. 4 to 6 have any doubt as regards the content of the complaint, they may have an opportunity to revert to the plaintiff and that the plaintiff may then seek clarificatory orders from this Court.

3. Learned Senior Counsel appearing for the applicant/ defendant No. 4 submits that the order passed by this Court has already been complied with and when URL was provided by the plaintiff to the defendant No. 4, the same has been disabled. The said statement is taken on record.

4. The present application is filed on behalf of defendant No. 4. However, learned counsel for the defendant No. 6 is present, who submits that a similar application for clarification has been filed on behalf of defendant No. 6 also which is likely to be listed shortly.

5. Issue notice.

6. Notice is accepted by the non-applicants. Let reply be filed within two weeks. Rejoinder thereto, if any, be filed within one week thereafter.
