1. Learned counsel for the applicant/plaintiff states that in view of the interim order dated 29.07.2022 as modified by order dated 29.02.2024, this application may be disposed of confirming the said injunction order.



2. Learned counsel for defendant nos. 1 to 3 seeks an adjournment to take instructions on the aforesaid submission.
3. Learned counsels for defendant nos. 4 to 6 state that they have already complied with the interim orders passed by this Court and therefore, seek deletion from the array of parties.
4. Learned counsels for defendant no. 4, defendant no. 5 and defendant no. 6 state that defendant no. 4, defendant no. 5 and defendant no. 6 be deleted from the array of parties. They state that defendant no. 4, defendant no. 5 and defendant no. 6 undertake that the said defendants shall continue to abide by the interim order dated 29.07.2022 as modified vide order dated 29.02.2024.
5. The aforesaid statement of defendant no. 4, defendant no. 5 and defendant no. 6 is taken on record and they are bound down to the same. Accordingly, defendant no. 4, defendant no. 5 and defendant no. 6 are deleted from the array of parties.
