Replication along with affidavit of admission/denial filed by plaintiff on 20.08.2022. Same is taken on record.

Accordingly, pleadings stand completed.

Thereafter, let a **joint schedule of documents incorporating all the documents** be filed by the plaintiff (s) in accordance with amended Delhi High Court rules. Defendant(s) shall duly cooperate with plaintiff(s) in timely preparation of joint schedule of documents.

Plaintiff(s) shall prepare a **draft joint schedule of documents within a week** and send a copy of the same to the defendant(s) through email/ speed post. Further, defendant(s) shall duly sign the same/file objections, as the case may be, within **a week** thereof,



failing which, it shall be deemed that defendant(s) has no objection thereto.

Thereafter, plaintiff(s) shall file Joint schedule of documents **duly signed by both the sides** in terms of amended Delhi High Court Rules **within a week**, after reconciling the objections raised by the defendant(s), if any. In case the defendant(s) does not revert to the draft schedule as sent by defendant(s), plaintiff (s) shall be at liberty to file the joint schedule of documents, along with proof of sending the same. Needless to say, in that case, the plaintiff (s) shall be at liberty to file joint schedule of documents exclusively signed by the plaintiff.

The joint schedule shall be filed through **e-filing as well as in hard copy**.

Parties are directed to strictly adhere to the directed timelines and shall be liable for imposition of costs in case of non-compliance.

Registry shall file a report on the next date on two aspects(a)regarding incorporation of all documents placed on record in the Joint Schedule of documents as filed. (b) whether joint schedule of documents has been duly signed by both the sides

In case, documents have been filed through e-filing, parties are directed to file hard copies of their documents in the Registry at least one week prior to the next date.
