CRL.M.(BAILES) 317/2025 & 284/2026 in CRL.A. 451/2020
(Seeking *Interim* Suspension of Sentence)

1. In the order dated 17th February, 2026, the learned Single Judge of this Court had noted that the *interim* suspension of sentence was granted to the appellant- Jaideep Singh Senger @ Atul Singh, *vide* Order dated 03rd July, 2024, and was last extended on 07th April, 2025; thereafter, the appeal was listed on five occasions between 17th April, 2025 till 17th February, 2026. However, neither was any order passed extending the *interim* suspension of sentence, nor does it appear that any request for such extension was made before the concerned Court.
2. Despite the above, we find that the appellant has still not surrendered, when admittedly, the period of *interim* suspension of sentence granted in his favour has long expired.
3. Before proceeding to consider his applications seeking further suspension of sentence, we require the appellant to first surrender.
4. The learned Senior Counsel for the appellant submits that the appellant is presently in Kanpur and will positively surrender by tomorrow, that is, 21st February, 2026.
5. The learned counsel for the respondent shall file the Status Report on or before 23rd February, 2026.
6. Latest Nominal Roll of the appellant be also requisitioned from the concerned Jail Superintendent to be filed on or before the next date



of hearing.

7. Re-list on 24th February, 2026.

8. A copy of this order be sent to the Jail Superintendent for compliance.
