1. Taking note of the directions given by Hon'ble Supreme Court in SLP (Crl) No. 2204/2026, learned Predecessor Bench heard arguments in these matters on 15.05.2026, 19.05.2026 and 26.05.2026. The following order was passed by learned Predecessor Bench on 26.05.2026: -

- a) *Arguments were further heard for some time on behalf of the appellant in CRL.A. 451/2020.*
- b) *The parties are directed to file their written submissions, not running into more than five pages and relevant case laws that they want to rely upon. Let the same be filed, at least two days prior to the next date of hearing with advance copy to the other side.*
- c) *At joint request, list on 20.07.2026, 21.07.2026, 22.07.2026, 23.07.2026.*
- d) *The order be uploaded on the website forthwith.*

2. On account of change in roster, these matters, it seems, were not placed before the said Bench. These could not be taken up by this Bench either on



20.07.2026, 21.07.2026 as arguments were being heard in several connected petitions related to '*Land for Jobs Scam*'.

3. Since substantial arguments have already been heard by learned Predecessor Bench presided over by Hon'ble Dr. Justice Swarana Kanta Sharma, subject to the orders of Hon'ble the Chief Justice, these matters be placed before the same learned Bench on 23.07.2026.
