1. The order dated 29.04.2024, perused. Vide the said order, the Hon'ble Court has directed that the auction of the suit property be done in terms of order dated 14.08.2023 and listed the matter before this court for finalisation of proclamation in terms of order dated 14.08.2023.

2. Mr. Uttam Datt, Advocate (Mob: 9810041776) is appointed as Court Commissioner to carry out the auction proceedings, in relation to the Subject Property in terms of order dated 14.08.2023. Learned Court Commissioner is directed to comply all the conditions as laid down in the order dated 14.08.2023 relating to the procedure for conducting auction of sale of property in question, relevant provision of Order XXI of CPC and other conditions as laid down in the aforesaid order.

3.	Proclamation be also made in the English Daily 'The Statesman' & Hindi Daily 'Jansatta'.	On or before 7 th July, 2024.
4.	Publication of proclamation of sale in Websites as per order dated 14.08.2023	On or before 7 th July, 2024.
5.	Date of return of publication	21 st July, 2024.
6.	Date & time of inspection of the suit property by the prospective buyers..	26 th July to 30 th July, 2024 between 10.00 am to 4.00 pm.
7.	Public auction of the suit property	17 th August, 2024.
